ADHD ASSESSMENT PROCESS

Hi there!

Thank you for reaching out about evaluating your child for Attention-Deficit/Hyperactivity Disorder (ADHD). To help us better understand your child's behavior at home and school, we use Vanderbilt forms, which gather valuable insights for the evaluation process.

We ask that you complete the parent form, sharing your observations of your child's behavior at home. If other caregivers have helpful input, they are welcome to complete a form too.

You can access the form by scanning the QR code below or visiting the URL. Just enter your child's name and date of birth to complete and submit the form electronically:

We've included a letter with a QR code for your child's teachers to complete the teacher form. Before sending it to school, please fill out your child's information at the top. It's important to get input from all of your child's teachers, so feel free to make additional copies if needed. A helpful approach is to give the forms to the school office or a guidance counselor to ensure they're distributed properly. Input from the entire teaching team is essential for understanding your child's behavior across different classroom settings.

Once we've received all the forms, we'll contact you to schedule a follow-up visit. During this appointment, we'll review the results and discuss any next steps.
